## THE LEADS TRAP FILE

### WHAT IS THE LEADS TRAP FILE?

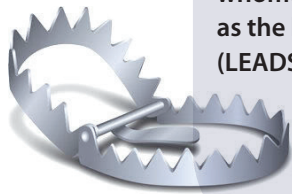
The LEADS Trap File is a database containing vehicle plate numbers, Social Security numbers, driver's license information, VIN numbers and any other pertinent information of officers engaged in high-risk investigations, covert operations, and/or surveillance.

### WHY WAS THE TRAP FILE CREATED?

Law enforcement agencies utilize unmarked/undercover vehicles to conduct covert operations and/or surveillance. In some cases, the law enforcement officers involved in the aforementioned operations have also been assigned cover identities. The nature of their work can result in unplanned contact with other law enforcement officers through traffic stops, citizens' complaints of suspicious actions, traffic crashes, and routine queries on vehicle registrations. There is always a concern the undercover officer's "cover" will be compromised accidentally during one of these unplanned contacts.

Also, during the course of an investigation, a law enforcement agency may want to be notified when a suspect(s) has been contacted by any law enforcement officers. (Officer Violator Contacts)

To assist law enforcement agencies with these types of operations LEADS developed and implemented a program known as the LEADS Trap File.



### HOW DOES THE TRAP FILE WORK?

When the administrator of an agency determines a LEADS Trap would be beneficial to officer safety and/or an investigation, the administrator contacts LEADS. The following information is to be provided to LEADS:

- The reason for the Trap
- The name of the officer (s) involved (Exact Match)
- The operator's license number of the officer (s) involved
- The social security number of the officer (s) involved
- The license plate number of the vehicle (s) involved
- The VIN number of the vehicle (s) involved

The same information should be supplied if the request is being submitted to track *Officer Violator Contacts* with a suspect.

The request for a LEADS Trap must include a 24-hour a day contact number for whomever the administrator designates as the law enforcement agency contact. (LEADS will not enter a Trap without a 24-hour a day contact person.)

Following the entry of this information, when any law enforcement agency makes a query of the entered trap information, the LEADS control room receives an alert. Upon receiving the alert, the 24 hour a day contact person is notified by LEADS their officer or suspect has been queried. They are provided with the name of the agency which made the query. In turn, they should contact the querying agency immediately to limit the possibility of compromising the officer's cover or losing a suspect.

Periodically, not less than twice a year, Trap entries shall be validated upon notification from LEADS. Failure to validate entries will result in the Trap being deleted from the system.

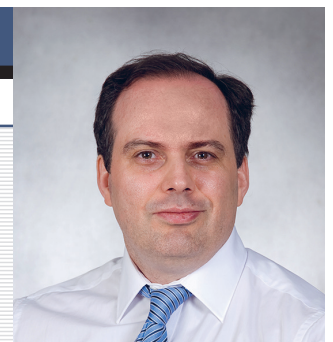
## WELCOME NEW EMPLOYEE

## STOLEN FRAUDULENT VS ALIAS

**P**er the January 2012 *LEADing News* newsletter, all S/F entries entered incorrectly should now be modified to AKAs. These will be listed as discrepancies by the auditors.



## OLN and MNU INFORMATION

**W**hen agencies make an entry into LEADS, it is their discretion to enter EXPIRED or SUSPENDED OLN's. However, when an agency enters an EXPIRED or SUSPENDED OLN, it is to be entered in the OLN field.

Remember, an OLN is still an OLN whether it is *current*, *expired* or *suspended* and should be entered in the OLN field.

If the subject has a *State ID*, enter it in the MNU field. It is also agency discretion to enter *expired State ID* numbers.

If an OLN has *no expiration date*, it does not have to be entered.

## Entering *Wanted Person* Records

### ADDING VEHICLE/LICENSE PLATE DATA

**W**hen vehicular data is entered, all entries and modifications will cross-search all person files (except the NICS *Denied Transaction and Unidentified Person Files*), *Vehicle*, *Boat*, *Vehicle/Boat Part* and *License Plate Files*.

A vehicle and/or license plate may be entered as part of a wanted person record (EW, EWJ, or ET) provided the location of the vehicle and/or license plate is unknown, and the entering agency has reasonable grounds to believe that the wanted person may be operating the vehicle or a vehicle bearing the license plate.

Mere knowledge or verification with the appropriate Department of Motor Vehicles that a vehicle and/or license plate is registered to the wanted person does not meet the criteria for entry of either or both as part of his/her wanted record. [NCIC Manual (Wanted Person)].

Also, if the agency chooses to enter the vehicle, during the validation of the warrant the vehicle information must be verified to ensure the vehicle has not been transferred to another individual (if so, it must be removed from the record).

## Still using Microsoft?

On **April 8, 2014**, Microsoft will terminate support for the *Windows XP* Operating System (OS). *Windows XP* is one of the longest running/supported OS's for Microsoft. By the time support ends, XP will have been around for over 12 years. Since XP, Microsoft has released *Vista*, *Windows 7*, and *Windows 8* OS's for the desktops.

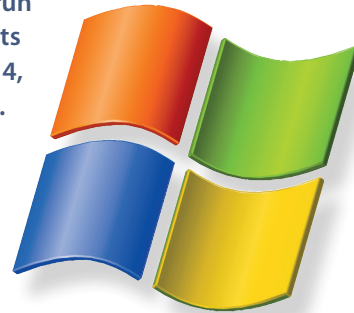
### So what does this really mean to you?

Effective April 8, 2014, there will be no further security updates for the *Microsoft XP* OS. Any exploits (viruses, worms, trojans, etc.) found near, or after April 8, 2014, will not be patched. The *Windows XP* OS will continue to run as normal, however, when Microsoft releases its patches on "Patch Tuesdays," after April 8, 2014, the *Microsoft XP* OS will no longer be included.

Since there will not be any further updates, *Windows XP* will become more vulnerable to exploits. New vulnerabilities will certainly be discovered that could impact *Windows XP* on a regular basis. Some of these vulnerabilities may be critical and could allow a hacker to take control or cripple a machine running *Windows XP*.

As such, on April 8, 2014, LEADS will no longer allow machines running *Windows XP* to connect to our network. Any machine found running *Windows XP*, on or after April 8, 2014, will be denied access to the LEADS network.
