

# Announcing LEADS Mobile Data Terminal (MDT) Service

Effective June 30, 2014, the Law Enforcement Officer Tool-Kit (LEOT) was decommissioned and the LEOT Mobile Data Terminal (MDT) Service was assumed by LEADS.

#### How much will it cost?

The MDT fee is \$100 per month and an additional \$5 per user, per month. (LEADS does not provide MDT equipment).

#### What is included?

A wide range of inquiries are available through LEADS Mobile such as, vehicle registrations (in-state/out of state) driver's license information (in-state/out-of-state) warrant information, computerized information (CCH) and Concealed Handgun Licenses.

### How will officers take the LEADS certification test?

Officers will have full access to nexTEST on their LEADS Mobile MDT.

### Who will be responsible for officer background checks?

The agency Terminal Agency Coordinator (TAC) will be responsible for all TAC duties, such as background checks, training, maintaining certification list, etc.

### What are the minimum computer requirements for LEADS Mobile?

Windows 7 or Windows 8 are acceptable. As of April 8, 2014, Windows XP is no longer supported by Microsoft. Any MDT found to be running Windows XP may not be permitted to have access to LEADS Mobile.

# FOR WINDOWS SERVER 2003 AND WINDOWS SERVER 2003 R2

Microsoft support for Windows Server 2003 and Windows Server 2003 R2 ends on July 14, 2015, which means the end of updates and patches, and a loss of compliance for any LEADS interfaced systems running the operating system (OS) after this date.

Any exploits (viruses, worms, trojans, etc.) found near, or after July 14, 2015, will not be patched. The Windows Server 2003 OS will continue to function normally, however, when Microsoft releases its patches on "Patch Tuesdays," after July 14, 2015, the Microsoft Server 2003 OS will no longer be included.

Since there will not be any further updates, Windows Server 2003 and Windows Server 2003 R2 will become more vulnerable to exploits. New vulnerabilities will certainly be discovered that could impact Windows Server 2003. Some of these vulnerabilities could allow a hacker to take control or cripple a machine running Windows Server 2003. As such, on July 14, 2015, machines running Windows Server 2003 or Windows Server 2003 R2 will no longer be permitted to interface with the LEADS network. Any machine found running either version of Windows Server 2003 on or after July 14, 2015, will be denied access to LEADS.

This applies to CAD, MDT, Records Management, Backup or any other kind of server that interfaces with the LEADS network.

Users currently running Windows
Server 2003 or Windows 2003 R2 are
recommended to upgrade to a newer
OS. As with most major changes to
operating systems, there may be some
problems with the actual installation
as well as with specific application

# NEWSLETTER DISTRIBUTION CHANGE

The LEADing News will now be distributed in April and October.

- The retention period is current year plus previous three years.
- Documentation must be maintained for auditing purposes.

### SECOND PARTY CHECK

Agencies that enter records in LEADS/ NCIC are responsible for their accuracy, timeliness, and completeness. The accuracy of LEADS/NCIC records is an integral part of the LEADS/ NCIC System. The accuracy

of a record must be double-checked by a second party at initial entry only. A modification of a record does not require a second party check.

### STOLEN GUN RECORDS

The Bureau of Alcohol, Tobacco and Firearms (ATF) has confirmed it will enter its own stolen gun entries on investigations of which it is a part. The recovering agency must send a LOCATE on the ATF entry for it to be cleared along with the original stolen gun entry.

### **BCI & DNA REGISTRATION**

When the Ohio Bureau of Criminal Investigation (BCI) has DNA on file for a subject, the top of its CCH response will indicate DNA is registered in the Ohio DNA Offender Database.

LEADS/NCIC and the Messenger form asks if DNA is available, only answer YES if your agency has DNA or another police department/sheriff's office has stated it has DNA. Do not base your answer on the CCH response indicating DNA is registered in the Ohio DNA

# LEADS/NCIC WARRANT ENTRIES (CIVIL)

The purpose of this article is to clarify questions regarding the entry of warrants into LEADS/NCIC that originate from a civil procedure or judgment. Letters were sent to the Buckeye State Sheriff's Association, the Ohio Association of Chiefs of Police and an administrative message was sent to all terminal agencies regarding the entry of civil warrants.

The criterion for the entry of "arrest warrants" stemming from a civil proceeding or judgment follows:

- There are no specific prohibitions for the entry of warrants "originating" from a civil proceeding or civil judgment. However, the threshold generally accepted for entry of warrants into NCIC is: the warrant must be "actionable", meaning the subject of the warrant can be arrested and taken into custody based on the issuance of the warrant.
- NCIC contains warrants for non-support of a child and bench warrants, which stem mainly from non-compliance with court orders, including failure to pay child support.
- There is no legal prohibition that would disallow "arrest warrants" issued in civil cases from being entered into NCIC.
- An entry may be made after: A decision to arrest or authorize arrest has been made and the decision has been made regarding extradition.

# **CORONERS REQUESTING LEADS INFORMATION**

Coroners who have an ORI ending in K and have an agreement with LEADS may have access to Missing Persons and Unidentified Files only. Agencies should not disseminate any additional information through LEADS. If more information is needed, the coroner may submit a request to ohiodlphotos@dps.state.oh.us.



## EMPLOYEE DRIVING RECORD REQUEST

Agencies are not permitted to routinely run BMV inquiries through LEADS on their employees. To check the status of an employee's driving record for administrative purposes only,

you may do so by setting up an account with the BMV. A letter on agency letterhead must be faxed to 614-995-7946 requesting external access to the BMV website. The letter should indicate the full name, email address and contact number of each individual requesting access.

> BMV inquiries and CCH can be run through LEADS when agencies are conducting an initial hire background check and/or the recommended five-year background update.



## Messenger LOG-IN

All Messenger agencies including inquiry only should log onto their terminals at least once a week.

Several terminals that have not signed on to read the upgrade message from August. LEADS only holds 25,000 messages in the undelivered queue and even one over will bring the system down. LEADS is monitoring stations with larger queues, and will start contacting agencies to inquire why they are down if there is no outstanding remedy ticket.
